Investment policy

The pension product, BVG-Mix 15 Plus, makes broadly diversified investments in the global financial markets. The focus, however, is on investments in Swiss equities, property and bonds. With a strategic equity allocation of 15 % and a tactical range of 5 % to 20 %, the product is conservatively structured. The investments are selected in compliance with the investment guidelines of the Ordinance on Occupational Retirement, Survivors' and Disability Pension Plans (BVV2). Depending on the prevailing economic situation as well as the assessment of the interest rate, equity market and exchange rate environments, controlled deviations from the investment strategy are undertaken within the permitted ranges.

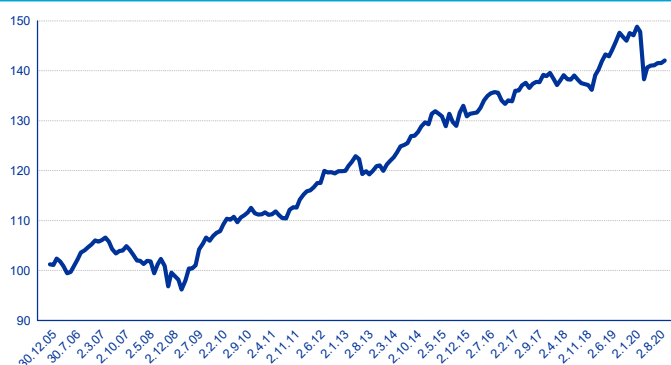

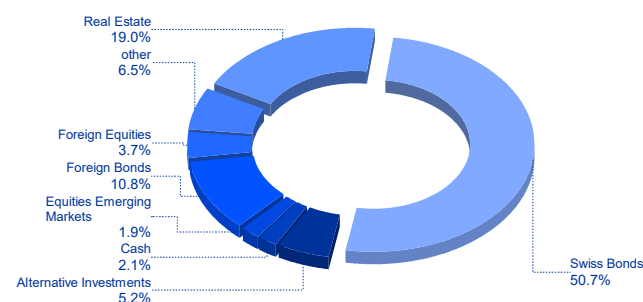

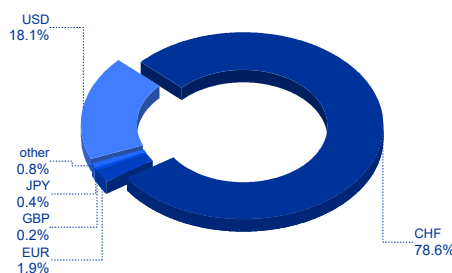
